## REMARKS

On 06/20/19 Ofc. Small and I were dispatched to a location in Middletown for a reported domestic incident. The caller, Offender #1, told Central Dispatch that she and her roommate, Victim #1, had a domestic. Victim #1 was described as an Asian male who had since left. Offender #1 further stated that they were arguing over their relationship status. It was reported that no weapons were involved, and that it was unknown where Victim #1 was at that time, but he drove a gray or silver Nissan.

Upon my arrival I observed an Asian male leaning against a Nissan in the parking lot in front of the entrance to the building containing #6412. Said male was identified as Victim #1, who was at that time carrying a small backpack. I was also aware that he and Offender #1 had been in a domestic incident a few days prior, where police were called, so we asked Central Dispatch to check for protective orders which may have been in place. Central Dispatch originally stated that full no-contact orders were in place, in which both parties were protectees and respondents. It was later confirmed that those orders had been dropped,

but new orders were now in place. Said new orders were issued by court, dated 06/18/19, and stipulated that (1) surrender or transfer all firearms and ammunition, and (2) do not assault, threaten, abuse, harass, follow, interfere with, or stalk the protected party.


Victim #1 provided video footage of the incident in which Offender #1 stood in front of his bedroom doorway, and when he attempted to walk past her, she grabbed his backpack that he was holding and tried to pull it away from him. During the course of the investigation it was determined that Offender #1 was the primary aggressor by grabbing the backpack of Victim #1, who had attempted to leave, and in doing so violated the protective order stipulations. During the arrest, Offender #1 was physically aggressive and non-compliant throughout, and in doing so, interfered with the investigation.

Offender #1 was charged with Criminal Violation of a Protective Order (C.G.S. 53a-223) and Interfering with an Officer (53a-167a). Offender #1 was further held on a \$25,000 surety bond pending arraignment on 06/20/19.

I observed that all of the plants at the front of the establishment had been ripped out of their planters and thrown to the ground.      pointed out the suspect and said "that's him". I walked over and made contact with the suspect.

The suspect was positively identified as Christopher Anderson      I observed potting soil on his shirt. I questioned Anderson as to what had taken place. At first he denied destroying the plants. I told him I could see the potting soil on his shirt, and again questioned what happened at the restaurant. Anderson then admitted that he was refused service at the bar and became upset so he destroyed the plants. He was advised that he would be arrested and he was no longer welcome at the establishment in the future. He stated he understood.

Anderson was issued MSC #MC 716049 and charged with 53a-117 Criminal Mischief in the 3rd degree.
