Tiano were walking towards the place of business we observed an individual walking northbound on Main Street crossing Court Street with numerous plants in his hands. He was yelling and causing a disturbance in front of a large group of people at the corner of Court Street and Main Street.

Upon making contact with the individual Fares Hashem, who was identified by his Connecticut Operators License # He stated he was trying to impress a girl and made a poor choice. Hashem had dirt on his hands and numerous flowers were scattered on the sidewalk and in the roadway on Court Street. REMARKS

On 07/10/19 at approximately 0119 hours, I, K9 Officer Aura Smith was traveling east on Grand Street and was turning south onto Main Street when I observed a tan Volvo parked on Main Street facing west with its hazard lights on and not parked in a marked stall. The drivers side window was down and the female operator was looking down at her cellular phone. Concerned that the operator was in distress or lost, I pulled next to her and asked if she was okay and advised her she wasn't parked in a parking stall. It should be noted that curb line she was parked in front of was painted yellow, indicating a no parking zone. Moreover, her vehicle was also parked perpendicular to the curb and the rear of her vehicle was partially blocking the right of two southbound travel lanes.

The operator was identified via her CT drivers license as Holly Hughes (60). During the investigation it was established that the accused had drinking alcoholic beverages that night and was operating under the influence. The accused failed the Standardized Field Sobriety tests and was consequently placed under

arrest and transported to police headquarters for processing.

At headquarters the accused refused to submit to a breath test. The accused was released on a five hundred dollar non-surety bond and assigned a court date at GA9 Middletown of Wednesday 07/18/19, 0900 hours where she will answer for the charges of, Improper Parking & Operating Under The Influence of Drugs/Alcohol and Possession of Drug Paraphernalia, in violation of CGS's 14-251 & 14-227a respectively.
