Linda Wallace called the meeting to order at 5:14PM.

Linda Wallace called for the Committee to review the minutes from the previous meeting.

Linda Wallance called for the first item under new business.

Richard Brass of Mercy Housing present his organizations request for an extension to their 2006 CDBG grant of \$6,000. Two problem resulted in this request, first Mercy Housing is required to obtain approval from Connecticut Valley Hospital for any alterations to the building. The approval process was lengthy. Second, the contractor hired for the project lost his full-time employee and is busy hiring and training a replacement to assist him in the renovations to the homeless shelter. Richard Brass expected to the work to be completed by October 1st, but was requesting an extension until November 31st to ensure that all the follow bill paying will be completed.

Grady Faulkner requested if the contract has committed to the October 1st deadline in writing. Richard Brass replied that the contract has committed to October 1st in writing.

Richard Pelletier motioned to approve the grant extension to November 31st, 2007. Barbara Plum seconded the motion and the motion was approved.

Linda Wallace called for the third item under new business, the 2004 CAPER and Line of Credit reimbursements. Michiel Wackers explained that in the 2004 grant year the Community Development Block Grant Program over expended in public service projects by \$6,444.87. This amount need to be return to the City's line of credit using non-federal funds, so that it can be made available for new eligible CDBG grant projects.

Richard Pelletier motioned to recommend that the Common Council reimburse the \$6,444.87 to the CDBG program. Barbara Plum seconded the motion and the motion was approved.
